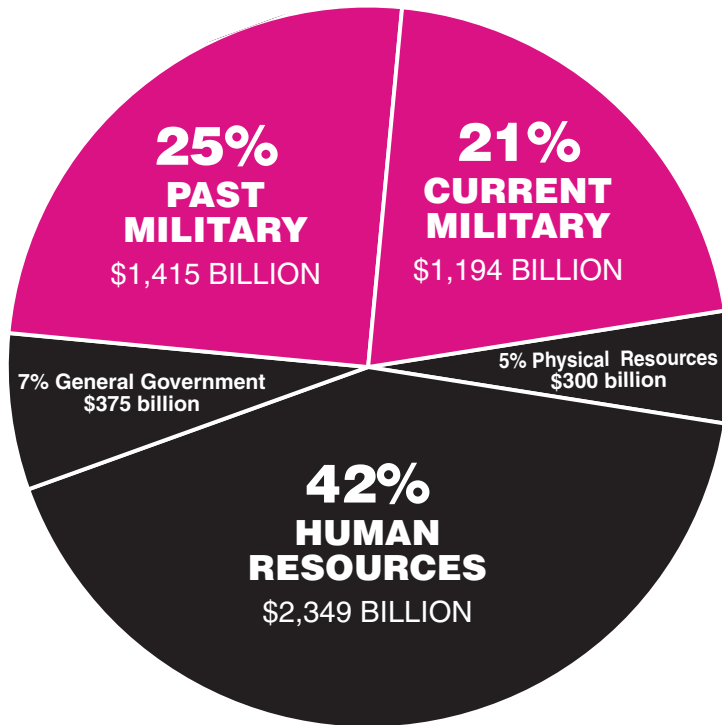


WHERE YOUR INCOME TAX MONEY REALLY GOES

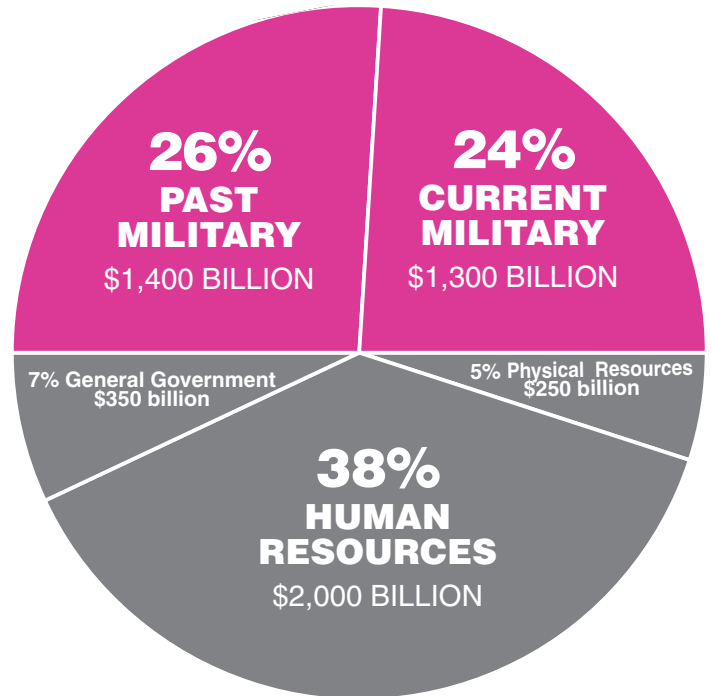
U.S. FEDERAL BUDGET 2026 FISCAL YEAR

Possible FY2026 Trump Budget

total military: 50% at \$2,700 billion
non-military: 50% at \$2,600 billion

These figures are from the FY2026 column in last year's *Analytical Perspectives* book of the *Budget of the United States Government, Fiscal Year 2025*. They are Federal funds, so do not include Trust funds — such as Social Security — which are raised and spent separately from income taxes.

“Current military” includes Dept. of Defense (\$880 billion) and the military portion (\$314 billion) from other departments and agencies, including Homeland Security, Energy (nuclear weapons), State, NSA, CIA. “Past military” represents veterans’ benefits (\$391 billion) plus 80% of the interest on the debt (\$1,023 billion).* For further explanation, please go to warresisters.org.

Income taxes, you pay (or don't pay) by April 15, 2025, go to the Federal funds portion of the budget. Potential cuts to Social Security and Medicare Trust Funds are not reflected on this flyer.

Because Trump has yet to release a budget proposal, presented here is a rough estimate of what the FY2026 budget (Oct. 1 – Sep. 30, 2026) might look like. The overall budget, projected to be smaller than the Biden proposal, is based on stated goals to eliminate the Dept. of Education, in addition to major cuts in Medicaid, housing assistance, food aid, energy credits, EPA, USAID, Labor, NSF, NASA, Interior, FEMA, IRS, as well as other departments and agencies, offsetting increases in military expenditures. These cuts will not offset major tax cuts for the rich and corporations, so the debt is expected to increase.

*Analysts differ on how much of the debt stems from the military; other groups estimate 50% to 60%. We use 80% because we believe if there had been no military spending, most of the national debt would have been eliminated.

WRONG WAY TO PEACE & PROSPERITY

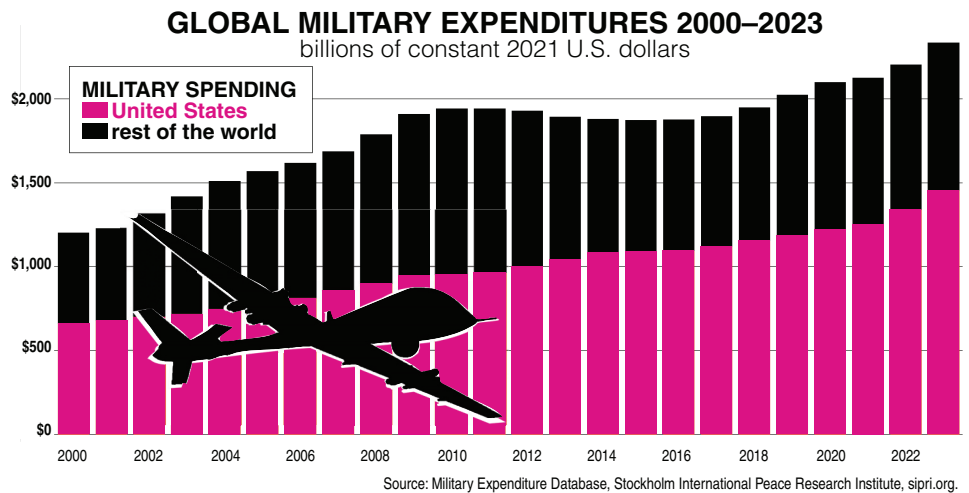
Over the past year, the world has witnessed an alarming escalation of violence, with catastrophic consequences. The genocide in **Gaza** and the war in **Ukraine**, plus over **30 other armed conflicts** in the Global South (half of them in Africa), together with increasingly aggressive and openly supremacist rhetoric and policies, have all contributed to a climate of instability and fear.

Despite the evident role of military force in all this, governments are responding by doubling down on the same **recipe for disaster** — **significantly increasing their military budgets**. Instead of seeking paths toward peace, investing in diplomacy, humanitarian aid, and conflict resolution, countries are allocating unprecedented amounts of resources to the arms industry. This dangerous trend not only fuels global tensions but also diverts crucial funds from social and environmental sectors, which truly improve lives and provide security.

In the United States, despite talk of ending wars, the president and Congress pushed through \$6 billion more for military spending and cut about \$13 billion from other parts of the FY 2025 budget. Pentagon priorities include further militarization of the Southern border, new nuclear weapons, a revived “Star Wars” missile defense system (a costly failure under Reagan), and enhanced U.S. military presence around China.*

History has repeatedly shown that **militarization brings neither peace nor security**; it perpetuates cycles of destruction, suffering, and injustice. We must demand an end to this reckless arms race. The world does not need more weapons. It needs dialogue, cooperation, and a commitment to justice and human dignity.
